

DESCRIPTION:

The Subject property is 477.4 acres comprised of 3 contiguous parcels. Currently planted to almonds, ages range from 13 years old to newly planted.

ACCESS:

Property has multiple accesses, by two different public paved roads. Internal access is dirt roads, with critical access areas having gravel and sand.

ZONING:

A-1 Agriculture

WILLIAMSON ACT:

The subject property is under contract pursuant to the California Land Conservation Act of 1965. (Williamson Act)

Parcel 074-140-030, 80.4 ac is excluded. (where growout sheds are located)

WATER:

The property has access to 2 sources of water, the first being through 7 deep wells and 4 booster pumps located at stations.

The entirety of the ranch is interconnected and the water from existing wells can be moved to any portion of the ranch for irrigation purposes. (Source 1)

Second source, Merced Irrigation District water by way of diversion weir and pumping station. (Subject to MID availability)

IRRIGATION SYSTEM:

The property is irrigated by micro sprinklers (342 ac +/-) & double line drip. (76.9 ac +/-)

In addition to micro sprinklers and drip system, the property has the ability to flood irrigate 100% of planted acres with a concrete pipeline system.

Infrastructure in place to receive secondary water from Merced Irrigation District. (Subject to MID availability)

UTILITIES:

Provided by PG&E with multiple meters, capable of high power demand.




PLANTING MAP
